ENROLLED, An Act,

To propose a local amendment to the Constitution of Alabama of 1901, relating to Cullman County, to provide that the term of office of the Revenue Commissioner would commence on December 1 following the general election in 2026, and every six years thereafter; and to provide that the term of the office of the incumbent revenue commissioner would expire on November 30, 2026.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The following amendment to the Constitution of Alabama of 1901, is proposed and shall become valid as a part of the Constitution when all requirements of this act are fulfilled:

PROPOSED AMENDMENT

Effective beginning the next term of office after the ratification of this amendment, the Revenue Commissioner of Cullman County shall take office on December 1 following the general election in November 2026, and every six years thereafter. In order to implement the change in the commencement of the term of the revenue commissioner provided above, the term of the Revenue Commissioner serving on the ratification of the amendment shall expire on November 30, 2026. The revenue commissioner shall continue to serve until a successor is elected and qualified.

1           Section 2. An election upon the proposed amendment  
2 shall be held in the general election in 2022 in accordance  
3 with Section 284.01 of the Constitution of Alabama of 1901,  
4 now appearing as Section 284.01 of the Official ReCompilation  
5 of the Constitution of Alabama of 1901, as amended, and the  
6 election laws of this state.

7           Section 3. The appropriate election official shall  
8 assign a ballot number for the proposed constitutional  
9 amendment on the election ballot and shall set forth the  
10 following description of the substance or subject matter of  
11 the proposed constitutional amendment:

12                 "Relating to Cullman County; proposing an amendment  
13 to the Constitution of Alabama of 1901, to provide that the  
14 term of office of the Revenue Commissioner would commence on  
15 December 1 following the general election in 2026, and every  
16 six years thereafter; and to provide that the term of the  
17 office of the incumbent revenue commissioner would expire on  
18 November 30, 2026.
