16 WHEREAS, Brenda R. Coone provided excellent 17 leadership, guidance, and knowledge of system deployment to 18 the department by championing the final development and launch 19 of the Optional Personal Property Assessment Link for the citizens of the state, by implementing call center services 20 21 for assistance to taxpayers for individual income tax and 22 motor vehicle inquires, by coordinating the efforts for the 23 transfer of administration to the department for fees and 24 taxes from different state agencies, and by further 25 streamlining internal processes of the department with remote
