ENROLLED, An Act,

Relating to Marengo County; to authorize the Marengo County Commission to impose an issuance fee to be levied and collected annually for each motor vehicle tag issued in Marengo County; and to provide that the proceeds shall be used to supply resources to the Marengo County Economic Development Authority and for improvements to the Marengo County road system as authorized by the county commission.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. This act shall only apply in Marengo County.

Section 2. (a) For purposes of this act, the term "motor vehicle" means a motor vehicle as defined in Section 40-12-240, Code of Alabama 1975, excluding any trailer qualifying as a utility trailer.

(b) The Marengo County Commission may levy an additional annual issuance fee, not to exceed five dollars (\$5), for each motor vehicle tag issued in the county or otherwise subject to ad valorem taxation by the county unless specifically exempted therefrom.

(c) The additional fee authorized by this section shall become due at the same time the state license and registration fee becomes due pursuant to Section 32-6-61 of the Code of Alabama 1975, provided that the additional annual

1 fee is not collected more than once in a 12-month period per
2 vehicle.

3 (d) Any fee levied pursuant to this section may be
4 removed at the discretion of the taxing authority provided the
5 removal does not affect any contractual obligation.

6 Section 3. Any person who is 65 years of age or
7 older, upon verified proof of age, shall be granted an
8 exemption from payment of the issuance fee levied pursuant to
9 Section 2 for one motor vehicle.

10 Section 4. The funds collected pursuant to this act
11 shall be deposited into a special fund to be held by the
12 respective taxing authority to be used to supply resources to
13 the Marengo County Economic Development Authority and for
14 improvements to the Marengo County road system as authorized
15 by the county commission.

16 Section 5. This act shall be repealed on October 1,
17 2022.

18 Section 6. This act shall become effective on
19 October 1, 2012, following its passage and approval by the
20 Governor, or its otherwise becoming law.
